7. Squeezer system: Operable from front side and must have provision for squeeze arrangement with push and pull panel made of SS rod of 10 mm diameter, located centrally and must be made of SS wire rod of 5 mm diameter at equal distance of 25x25 mm (grill mesh). Must have provision for multi lock holes in the push & pull rod at different points at a distance of 50 mm. Length of squeezing rod exposed outside cage during static condition must be 120 mm.
8. Excreta tray: Each cage must be provided with individual bottom excreta tray made of SS 316, 20 SWG sheet of 40 mm depth, inclined backside with centrally located handle having access from front with locking system and must be aligned with the cage frame. Tray must be made sturdy with round edges and firm welding.
9. Feed hopper: Cages must be with adjustable & removable feed hopper suitable for monkey in the front side (holding capacity of ~500g).
10. Water supply: Cages must have provision for replaceable automatic supply system of drinking water and must have additional manual SS hanger holding 500 mL SS water bowl with straw sipper to be affixed in cage walls.
11. Cardholder: Cages must have provision for secured cage card holder groove /slot of size 100X80mm affixed in each cage at the top corners of front wall frame.
12. Overall cage dimension: ~700-760X700-760 X 900-950 mm.

4. Floor: Grill mesh (20x20 mm, SS 316) type rod of 6 mm diameter at equal distance supported with three 10 mm diameter bars at equal distance.

5. Front: Vertical SS rod of 12 mm diameter welded at equal distance of 50 mm at SS frame and with provision of a SS rod panel of size 230x680 mm (WxH) operable vertically with suitable locking system to hold the door at 3 different positions (bottom, middle & top) and a firm appropriate advanced locking system at the bottom to prevent animals from escape.

6. Squeezer system: Operable from front side and must have provision for squeezer arrangement with push and pull panel made of SS rod of 10 mm diameter, located centrally and must be made of SS wire rod of 5 mm diameter at equal distance of 25x25 mm (grill mesh). Must have provision for multi lock holes in the push & pull rod at different points at a distance of 50 mm. Length of squeezing rod exposed outside cage during static condition must be 120 mm.

7. Excreta tray: Each cage must be provided with individual bottom excreta tray made of SS316, 20 SWG sheet of ~40mm depth, inclined backside with centrally located handle having access from front with locking system and must be aligned with the cage frame. Tray must be made sturdy with round edges and firm welding.

8. Feed hopper: Cages must be with adjustable & removable feed hopper suitable for monkey in the front side (holding capacity of ~500g).

9. Water supply: Cages must have provision for replaceable automatic supply system of drinking water and must have additional manual SS hanger holding 500 mL SS water bowl with straw sipper to be affixed in cage walls:
