2. The Director ICMR-NARFBR reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason thereof and does not bind itself to accept lowest quotations.
3. Participation in this tender is by invitation only and is limited to the selected procuring entity's registered suppliers. Unsolicited offers are liable to be ignored. However, suppliers who desire to participate in such tenders in future may bring it to the notice of procuring entity and apply for registration as per procedure.
4. The prices quoted should be firm till the supplies are completed. Please quote the rates in words and figures. Rates quoted should be **free delivery** at destination including all charges otherwise the quotation is likely to be rejected.
